## MANURE MANAGEMENT PLAN

This manure management plan has been prepared for Morton Ley Farm, Morton, Oswestry, Shropshire, SY10 8BG.

All manure produced by the proposed development will be taken to a local AD plant.

The manure management plan has been prepared for the total stock of 270,000 broilers.

The total produced on the farm is 89,100kg N, and therefore manure will have to be exported (Table 1).

89,100 kg N will be exported to AD plants (see letter appended below).

The manure storage and disposal will also need to accord with DEFRA's Code of Good Agricultural Practice for the Protection of Air, Water and Soil.
