Wild Cherry (T1)- Fell young tree encroaching on building [Picture: Cherry sucker growth to be removed T1.jpg]. It is not suitable for replacement planting in this area, as there is sufficient tree density to retain tree canopy.

Birch (T2) – Fell to prevent the tree from suppressing neighbouring Oak [Picture: Birch T2 fell.jpg]. It is not suitable for replacement planting in this area, as there is sufficient tree regeneration in this area to retain tree canopy.

Wild Cherry (T3) – Remove two branches on the South side that are suppressing neighbouring Oak tree [Picture: Cherry T3 two limbs to be removed to allow room for growth of neighbouring Oak.jpg]

Birch (T4) – Prune lateral growth to provide 2m clearance neighbouring Oak tree.

Sycamore (T5) – fell because tree has extensive squirrel damage and has lost amenity value [Picture: T5 Extensive squirrel damage.jpg]. It is not suitable for replacement planting in this area, as there is sufficient tree planting in this area to retain tree canopy.

Sycamore (T6) – fell because this stump regrowth has extensive squirrel damage and has lost amenity value. [Picture: T6 old stump regrowth with low amenity value.jpg]. It is not suitable for replacement planting in this area, as there is sufficient tree planting in this area to retain tree canopy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
