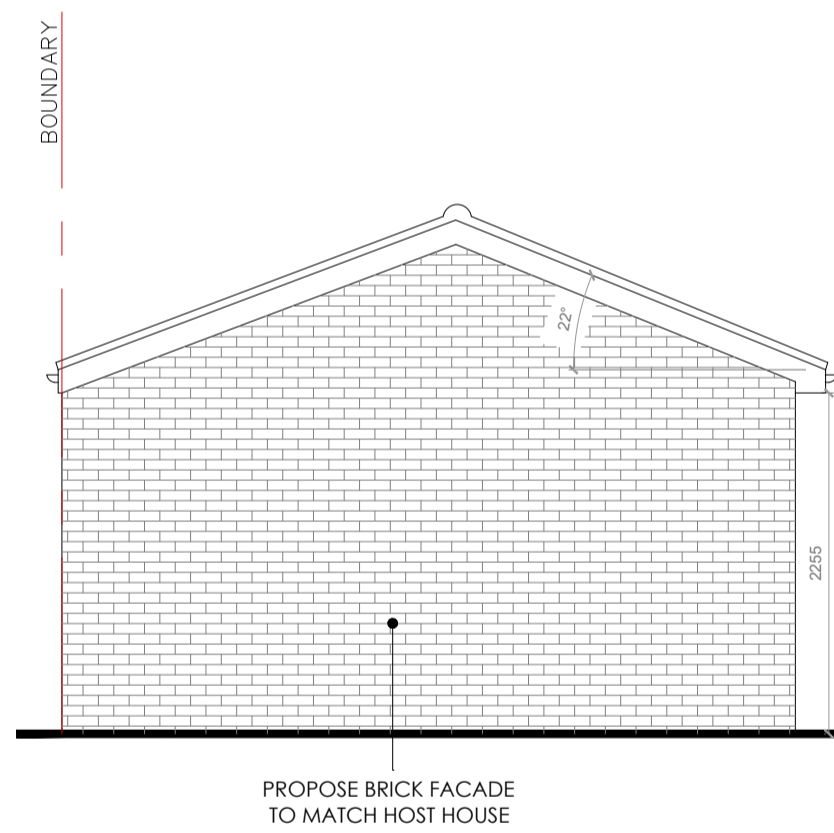


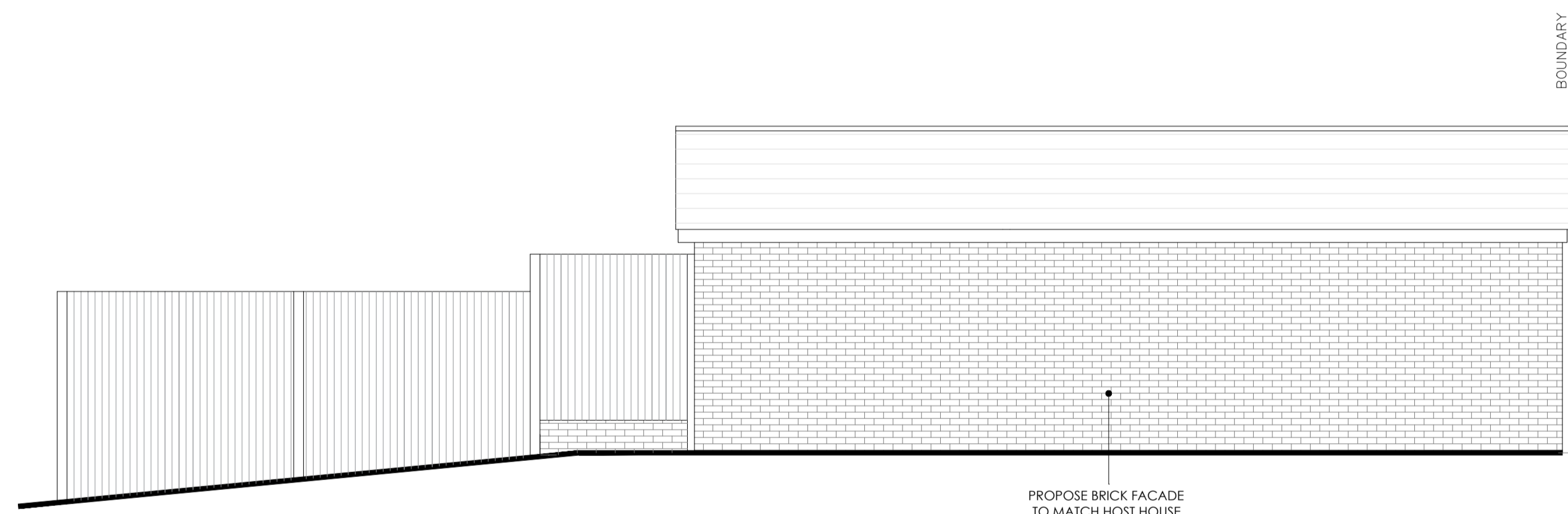
PROPOSED FRONT ELEVATION NE

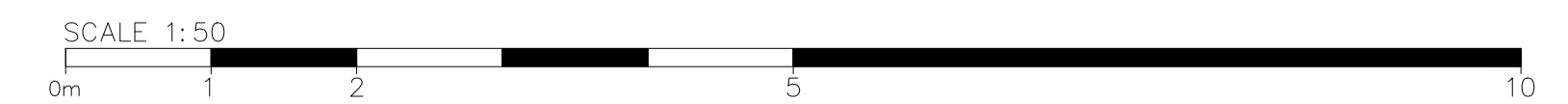
PROPOSED SIDE ELEVATION SE
