T3 Box tag 1241 - Fell to Ground Level dead

T8 Common beech tag 1277- Crown Lift Over Car Park/ Footpath to 2.5m

T9 Common beech tag 786 - Crown Lift Over Car Park/ Footpath. Reduce branches overhanging shed back to suitable growth points to provide clearance.

T10 Ash species tag 1253 - Prune to Clear Fence by 1m to prevent future damage

T12 Holly tag 1702 - Reduce branches overhanging neighbours garden. Reduce by approximately 2m back to appropriate growth points to prevent damage to fence and crown raise.

T21 Pedunculate Oak tag 1245 - Carry out crown reduction on side of BUPA building. Reduce branches by approximately 3m back to appropriate growth points to reduce tree away from building and balance crown. Final crown height to stay the same only lateral prune away from building. Lateral branches to be left at approximately 6/7m after pruning. Opposite side of tree has been historically pruned these works will provide a more balanced crown.

T27 Common beech tag 1247 - Carry out crown reduction reduce by approximately 1m back to appropriate growth points to reduce strain on included union. Final crown height approximately 19m

T28 Sycamore tag 1705 - Fell to ground level decay on stem.

T29 Common beech tag 533 Sever and Remove Ivy to 1.5m Above Ground Level, Clear all vegetation from base of tree.
