A single Leyland cyprus tree planted c.40 years ago marked with an arrow on attached plan. Planted as a garden shrub and now proving too large for its location. Tree is undermining garden wall, roof plate lifts in high winds and it is adjacent to public road and bus stop. Works are to totally remove the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
