T1 - Sycamore. Fell. Tree has significantly been crown lifted over many years, covered in Ivy which is difficult to inspect the union of twin stems. Reports of branch drop. Significant shading and debris in gutters and on roof throughout the year. Proposed replacement with minimum 2x fruit trees (pear, cherry or plum)

T2 - Sycamore. Fell. Tree growing through phone lines and adjacent to busy corner where cars park and people walk past to the very busy public house opposite. reports of small branch drop and nuisance throughout the year from shading, gutters filling and debris on roof.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - · showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
