T1: Eucalyptus

Issue: mature tree, leaning to the east over party wall due to close planting and now endangering neighbouring property (6B Greenside) with roof damage or property damage from falling limbs or storm damage. Trunk within 1 metre from party wall and owners outbuilding, cracks and movement in party wall and outbuilding linked to root related ground heave. Contributing to active and progressive structural issues to party wall and outbuilding.

Action: top and fell. Replant with smaller tree (e.g. ornamental cherry) at an appropriate distance from party wall and outbuilding.

T2: Walnut

Issue: mature tree, with unnatural form due to close planting (fan shaped and unnaturally elongated limbs). Overhanging limbs to owners outbuilding and neighbouring property (6A Greenside) endangering outbuilding and neighbouring property with roof damage or property damage from falling limbs or storm damage. Trunk within 1 metre from outbuilding, cracks and movement in outbuilding linked to root related ground heave. Contributing to active and progressive structural issues to outbuilding.

Action: top and fell. Replant with smaller tree (e.g. ornamental cherry) at an appropriate distance from outbuilding.

T3: Maple

Issue: mature tree, with unnatural form due to close planting (fan shaped and unnaturally elongated limbs). Overhanging limbs to owners outbuilding and neighbouring property (6A Greenside) endangering outbuilding and neighbouring property with roof damage or property damage from falling limbs or storm damage. Trunk within 1 metre from outbuilding, cracks and movement in outbuilding linked to root related ground heave. Contributing to active and progressive structural issues to outbuilding.

Action: top and fell. Replant with smaller tree (e.g. ornamental cherry) at an appropriate distance from outbuilding.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
