To fell Oak (T1) is listing heavily towards dwelling. Due to its poor form a reduction to mitigate the risk will leave a crown too small to support the tree. A primary leader was historically lost in inclement weather and as such no aesthetic appeal

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
