Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The two trees at the end of our garden are part of a group of nine trees which we planted over 40 years ago. The area is now somewhat congested and we think it would benefit from their removal or partial removal. Tree no 1 is a multi-stemmed Willow with 4 main trunks, each of about 12" diameter. We propose leaving one or two trunks and removing the others. Tree no 2 is an Italian Alder which is now nearly 50' tall and takes a lot of light from the other trees, which are Hazel, Birch (2), Larch, Oak and Hawthorn (2). We would like to fell this as it is in the centre of the group, in order to create more light. We will be using a fully qualified tree climber, who will take the trees down in sections.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
