Details of the pre-application advice received

Planning enforcement were contacted following the removal of a number of the existing property walls due to structural instability upon carrying out works on site, and the situation was discussed at length about how to address the situation and ensure correct Planning Procedures were followed. The above named Planning Enforcement Officer advised that we would be best served submitting a new Planning Application to ensure no unauthorised work was carried out. The named Officer stated that he appreciated that the final build would have been exactly as per the approved Planning Drawings and that no material harm would be likely; however the correct process must be followed.

This has also been discussed with Seniors/Team Leaders who were not minded to take enforcement action; however as discussed; all concerned want to ensure everything is done following the correct process.
