To carefully remove existing windows from stone surrounds and to supply, fix and glaze the following purpose made hot dip galvanized polyester powder coated steel windows complete with hermetically sealed double-glazed units and primed hardwood timber subframes to suit.

Windows made using slim W20 sections hung on close fitting barrel hinges with brass pins, fitted with weatherstripping and having good quality locking handles and stays. Windows where necessary made small pane with a 'T' glazing bar. Double-glazed units made using low 'E' glass with a gas filled cavity. Where leaded lights are required h" darkened lead strips will be applied to both sides of the outside pane with hand soldered joints. Hardwood timber subframes constructed using Ex. 3" x 3" for the head, jambs and sills.

- Galvanised windows and doors to be powder coated to BSEN 12004
- Double glazed units manufactured to BSEN 1279 with float glass standard EN 572 and toughened glass to BSEN 12150
