G1 - To reduce height of 3x Holly trees located in left hand side border, by approx. 1.5m.
T2 - To crown reduce Photinia by approx 1m all round.
Justification: to maintain size of the trees, prevent them from becoming a dominant feature of the garden and prevent them out competing surrounding smaller trees and shrubs for light.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
