Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1 - Oak Tree - Crown lift to 4.5m above ground level over the car parking area. Removing epicormic growth from the trunk.
 - T2 - Group of Sycamores - crown lift over car park to 4.5m, felling elongated sapling that has grown at 45 degrees over the garden to the rear, to approx ground level. Reducing branches on this group of Trees overhanging the garden to the rear by up to 4m back to the boundary line, to eliminate overhang.
 - T3 - Large Sycamore Tree - Remove 4 lowest branches over the car park.
 - T4 - Smaller Sycamore Tree - crown lift to 4m over the car park
 - T5 - Walnut Tree - Removing branch overhanging the Car Park, back to the main trunk.
 - T6 - Yew Tree - Reducing back from the Car Park by approx 1-2m.
 - T7 - Sycamore/Ash Saplings - Fell to ground level around the Lamp Post.
 - T8 - Oak Tree - Crown lift to 4.5m over Car Park area.
 - T9 - Holly Tree - Reduce back branches overhanging car park by 1-2m, back to edge of hard standing area.
 - T10 - Ivy Covered Hawthorn Tree - Fell to ground level, tree trunk has already split under the weight of the Ivy, Tree held up by Ivy, fell safety purposes.
- Reasons for work are to aid better access to the Car Park, and to tidy the Trees on the perimeter for aesthetic purposes

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
