T1 Ash Tree - Fell to ground level, Tree borders Crown Lane and half the Tree is dead. T2 Yew Tree - Crown lift over graveyard to 4m above ground level.

Works to reduce risk of tree failure into Crown Lane, Crown lifting to let more light under the Yew Tree.
