T1- Arbutus - Reduce and reshape the overall crown size of the tree radially back to the most recent pruning points by removal of up to approximately 1.5-2metres in height and up to approximately 1metre in lateral width.

T2- Laurel - Reduce and reshape the overall crown size of the tree radially back to the most recent pruning points by removal of up to approximately 2metres.

- T3- Cypress Reduce the overall height of the tree back to the most recent topping points. Re-trim all remaining sides as hard as possible whilst retaining healthy growth.
- T4- Maple Reduce and reshape the overall crown size of the tree radially by removal of up to approximately 1.5-2metres in height and up to approximately 1metre in lateral width.
- T5- Purple Plum Reduce the crown by removal of 3metres all round to reduce the weight and likelihood of failure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
