Retain an existing heat exchange from the cellar cooling system, the previous heat exchange unit was installed in a cavity within the old double front door, this was deemed a health and fire risk due to lack of ventilation, the heat exchange needs to be sited outside and this location is the least obtrusive.

The heat exchange will be covered by a wood trellis to allow for plants to grow and form part of a decorative garden, the trellis will measure no more than 1m long by 80cm high and to the wall behind at 50cm deep

The heat exchange is 83cm long, 71cm high and 33cm deep, it runs at a maximum sound level of 29dB which for reference is classed as quieter than a whispered conversation

The heat exchange is essential to the running of the pub keeping the cellar at a constant 12 degrees C for the safe and correct storage of beer
