Details of the pre-application advice received

Notwithstanding the in principle support for the conversion of the u shaped barn range and potentially for the butcher's shop building we are concerned about the provision of amenity areas and access and parking to the proposed residential units and the additional potential impact on the setting of the Conservation Area and on designated and undesignated heritage assets. There is also some concern about the degree of rebuilding required to convert the western area of the u shaped range. Conversion of the Dutch barn would not respect its character, appearance, or form and the amount of new building required would not accord with relevant policies. Any proposal to replace the butcher's shop building would not be supported in this location. Further information will also be required with regard to change of use of land, environmental impact, flood risk and highways impact.
