Notes to support application for pruning yew tree at Yew Tree Cottage, GL68AW

This application is made in respect of a request to reduce the crown of a yew tree located in the garden of Yew Tree Cottage and overhanging 'The Pitch' in Brownshill. Yew Tree Cottage is sited in a Conservation Area, hence this application

The tree is of significant age and probably was planted shortly after the cottage was constructed, c. 1730, and is a local landmark.

The yew tree has been pruned from time to time to keep from encroaching on the "The Pitch" and the garden of the cottage. It is pruned to a globe-shape.

It was last pruned in 2012 (planning approval, your ref. S.12/0652\TCA) and has grown significantly since then. The proposal is to reduce the crown by 35% to 45% and to maintain the globe shape

#### Reasons

- 1. To improve the visibility of road users on The Pitch
- 2. To improve the health of the yew tree
- 3. To free the BT cable which is trapping the cable to the house and causing problems with the phone/internet connection
- 4. To improve light to the house and garden

### Contractors

The applicant has consulted with Thames Tree Services (t.01793 751675, contact Kevin Ritchings), who will be undertaking the work.

### Timescale

The plan is to undertake this work by the end of February, before the bird nesting season. A decision is sought by mid February to allow for scheduling the work.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
