## 1. <u>Description of Proposal</u>

Unless we hear from you to the contrary, in writing, we will assume that you are agreeable to any revisions made.

The Council will aim to make a decision on your application within eight weeks of the date when it was received in proper form (thirteen weeks for major applications). This is a target set by central Government and if no decision has been reached after this date, you have the right to lodge an appeal to the Secretary of State. This will result in the application being determined by a Government-appointed Inspector instead of the Council. You may, however, agree to the Council taking longer than statutory period to determine your application. In all circumstances where this is the case, the Council will make a decision as soon as possible after the eight or thirteen week period.
