Identification of Tree(s) and Description of Works		
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out		
I wish to prune two mature cherry trees in our back garden. The trees stand about three metres apart are situated adjacent to the boundary wall with North Bristol Post 16 Centre (the old sixth form centre for Cotham School).		
They were last pruned by Gordano Tree Care in June 2022 (an application was submitted and this is just a repeat of that) and need to be repruned next summer as the branches are now extending over the school property and also above the level of our telephone line so I need to reduce the lateral spread on the N/W side by approx 3m to bring the edge of the crown in line with the dividing garden wall, to clear the school buildings and to prune the upper branches clear of the phone cable, a process I suspect needs to be repeated every two to three years.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
