Sweet Chestnut (G6) - Crown lift to 5m above driveway of 5 Furze Hill Road by removing low branches and removing excessive epicormic regrowth from the centre of the crown up to a height of 8m. 10% thinning as carried out under previous applications

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
