Removal of tree in rear garden. The tree was originally planted far to close to it's neighbouring Beech and Oak trees and is now stunting the canopy development of both trees that would otherwise thrive

## Identification of Tree(s) and Description of Works

Removal of Ash tree. Ash tree will likely die due to ash dieback in years to come. Currently however it is growing into neighbouring beech tree and oak tree (both are planted within 2 metres). The Oak and beech are magnificant trees that need both the light and soil nutients to thrive but they are currently being twarted by the faster and more invasive ash tree.

4 new saplings (2 ash, 2 weeping willow) have already been planted alongside the nearby stream edge which is in need of planting.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
