Following Matt Wilson - ISA Certified Arborist's visit on 29 November 2023, the following was agreed with the applicant:

(1) Bifurcated Willow by the parking area, leaning towards the garage and down the drive. Fell to near ground level.

(2) Ivy covered Willow by the fence, leaning towards the BT pole. Fell to near ground level.

- (4) Copse to the left of the drive entrance.
- Fell the small Apple leaning over the drive.
- · Fell the adjacent Apple leaning in.
- Fell the privet surrounding the Apple.
- (5) Small Sycamore and small Hawthorn by the front wall. Fell to near ground level.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
