Removal of two smallish trees, one a holly tree. One is close to the front boundary and Holly tree in front garden. I have recently had to have

close to £1,000 of remedial works carried out in the drains due to ingress of roots blocking almost half the drain. This is the only drain on the property and serves the bathroom, toilet and kitchen - all at the front of the property). Both trees could be causing the problem. The trees are

no more than a few feet from the main drain. There is no TPO on the property.

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

(1) Holly tree

- approximately 7-8 ft (some growth of top branch to about 10 ft)
- location front garden, 6 ft from front of property and x ft from drains
- full removal due to ingress in drains (recent work carried out to remedy half drain being blocked with roots)

(2) Laburnum tree

- approximately 12
- location front boundary by gate
- full removal due to ingress in drains (recent work carried out to remedy half drain being blocked with roots)

The one and only drain to the property passes within 2@3 ft of the Holly and Laburnum tree. This is the reason for the request.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
