The Original Application (23/02327/FHA) was withdrawn due to the Proposed Roof Ridge being above the Existing & also Not being a Gable End to the Front as the majority of the properties in Gravel Lane.
Also the Single Storey Rear Extension caused an issue with the 45 Degree Sight Line of No. 86.
Both of these issues have now been addressed.
