- EXISTING SERVICES AND STATUTORY UNDERTAKERS APPARATUS THAT INTERSECT PROPOSED EXCAVATIONS BEFORE BEGINNING ANY WORK. WHERE NECESSARY, ALL EXCAVATED MATERIAL SHALL BE
- DISPOSED OF AT AN APPROVED TIP OFF-SITE. THE PUBLIC HIGHWAY AND WORKS WILL BE KEPT CLEAN AND

ADOPTION NOTES

- ALL WORKS FOR ADOPTION UNDER A SECTION 38 AGREEMENT MUST COMPLY WITH THE HIGHWAY AUTHORITY SPECIFICATION FOR ROAD CONSTRUCTION IN RESIDENTIAL AREAS AND TO THE APPROVAL OF THE AREA HIGHWAY AUTHORITY.
- THE WORKS THAT ARE INTENDED TO BE ADOPTED THROUGH A SECTION 104 AGREEMENT MUST COMPLY WITH THE SEWER SECTOR GUIDANCE (JUNE 2022), RELEVANT APPENDICES AND MEET THE REQUIREMENTS OF THE DRAINAGE AUTHORITY.
- ANY WORKS CARRIED OUT ON-SITE BEFORE RECEIVING TECHNICAL APPROVAL FOR SECTION 104 AND SECTION 38 AGREEMENTS (INCLUDING STREET LIGHTING APPROVAL) WILL BE
- ENTIRELY AT THE DEVELOPER'S RISK. PRIOR TO THE COMMENCEMENT OF STREETLIGHT ERECTION, THE LOCAL AUTHORITY MUST APPROVE AND AGREE ON THE ON-SITE
- PEGGING OF STREETLIGHT POSITIONS. HIGHWAY INSPECTOR TO BE PRESENT DURING INSPECTIONS/ CBR TESTING
- STREET NAME PLATES LOCATIONS TO BE AGREED ON SITE WITH THE CLARK OF WORKS
