Application to crown an ornamental tree in the garden of a property (Daubeney House) which lies in a conservation area. The tree is a hybrid, planted by the previous owner, with one species grafted onto another. When moving into the property, it was about 10ft high, but the attached photograph shows that it has now grown very tall (c.30ft.) and very unevenly, because of the twin species growing at very different rates. It now overhangs the neighbour's garden, and also presents a hygiene problem in the garden of Daubeney House - persistent pigeon droppings do not disappear on the astroturf below the tree. This is a particular issue for my disabled son and his carers, which is why I am applying on their behalf for reduction work on the tree. The work will be carried out by a qualified arborist, who previously worked on a diseased cherry tree in this garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
