Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We would like to carry out the following works to continue to maintain and enhance the area and habitat of this piece of land which lies alongside the Langham Brook within the village conservation area. We have taken advice from a tree surgeon who has closely inspected the trees and suggested the following works would be appropriate given their current state and the proximity to three other large trees.

1) Fell Ash Trees (T1) – This clump of young multi stemmed self-seeded Ash Trees are growing very close together alongside the boundary. They are also growing at an angle towards the neighbouring property.

2) Fell Elderberry Tree (T2) – This tree is in very poor health and is growing extremely close to the boundary fence with the neighbouring property.

After removal of this clump of trees a replacement Alder tree would be planted. This tree will thrive in waterside habitat and will help to stabilise the bank. The current Hawthorn to the left of the trees will be able to grow up will also help provide more stability to the bank.

3) Fell young sycamore trees (T3). These two young trees are growing out of the bank and are unstable. There is already a very large multi stemmed sycamore within approximately 5 m of these trees. We would like to replace these with an Alder. To the right of these trees we intend to plant Hazel as well as some Basket Willow.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\,$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
