T1 diseased/dead rowan which needs to be removed, including roots.

T2 is a rowan of current height around 5 metres. It has grown in a miss-shaped way due to crowding at its base. The plan is to remove this tree.

T3 is a small twisted hazel (height ~ 4 metres). The plan is to remove this tree.

The space created by removing these trees will be replaced with a number of fruit trees (apple & plum) at a suitable spacing.

T4 is a row of hazels on the other side of the fence line that have previously been coppiced or pollarded. Since then the trees have grown to a height of approx. 8 metres with some branches overhanging the fence line. The plan is to reduce the height and spread of these back to the previous coppiced height, which is slightly above the fence line (~2m).

This tree work is required to allow sufficient light for the more suitable fruit trees that will be planted and to prevent damage to the fence.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
