9. Quercus rubor (oak).

Reduce overall crown by 1.5m, with the exception of the Eastern side of the crown which is heavily unbalanced and should be reduced back by 3m to improve the balance the tree.

Remove major dead wood.

Raise crown to 3m from ground level.

The tree is over-shadowing the neighbouring garden, encroaching onto no 3 and also causing light issues.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
