Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

1- Sycamore, Acer pseudoplatanus. (North East Boundary).

Remove major deadwood. Or Fell if sooty bark disease, Cryptostroma corticale, has caused extensive dieback of the crown. The extent of damage will be more visible when work is carried out or once the tree comes back into leaf. I suspect that the tree will need to be removed.

- 2- Sycamore, Acer pseudoplatanus. Fell (West corner). Tree is infected with sooty bark disease, Cryptostroma corticale.
- 3- Ash, Fraxinus excelsior. Reduce sub-dominant stem to the Northwest to lessen loading on tight 'v-shaped' union. Remove major deadwood. Current dimensions-NW-5meters N-5meters S-5meters W-5meters H-11meters

Proposed dimensions- NW-3.5meters N-5meters E-5meters S-5meters W-5meters H-9.5meters (on NW side)

- 4- Sycamore, Acer pseudoplatanus. Fell. Tree is infected with Sooty Bark Disease, Cryptostroma corticale.
- 5- Two dead Elm, Ulmus glabra . Fell to approximately 8ft. These trees are infected with dutch Elm disease, Ophiostoma Novo-ulm.
- 6- Yew, Taxus bacata. Reduce. Reduce canopy by 1m to form a smaller natural form. Remove deadwood and raise crown to 2.5m.

Current dimensions- N-4meters E-4meters S-4meters W-2meters H7.5meters

Proposed dimensions N-3meters E-3meters S-3meters W-2meters H7meters

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
