Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Cypress - Remove – Specification to include complete removal by sectional dismantling to ground level. Stump removal by mechanical stump grinding machine to a depth below ground level of 300mm.

Due to the driveway damage caused by roots (see images T1.1 and T1.2), major root pruning required to facilitate driveway repairs, which may render the tree unstable in high winds, therefore removal to ground and grinding out of stump is required.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
