Identification of Tree(s) and Description of Works

Works advised by Mr Bill Whisker, Tree Officer, on a site visit on the 19th of October 2023. The trees have also been reviewed by Walkers Tree Services and Treexpert Tree Care Ltd, who concur.

All trees detailed are for complete removal (and stump grinding if required).

No TPO's in place - but the trees are in a Conservation Area.

The web form does not allow enough characters for detailed description. Please see the attachment "Tree works in WFMG suggested by Mr Bill Whisker 19.10.2023" which has more detail and better formatting.

Shed 1 (Silver metal) – Shed 2 (Brown wood) Two Ash trees between the first and second sheds need to be removed - significant ash die back and signs of stress.

Sheds 2 (brown wood) – Shed 3 (empty plot – previously blue metal container) The six ash trunks (with shared root systems) between sheds 2 & plot 3 have ash die back, are stressed and need to be removed.

Plot of shed 3 (Blue container here has been removed earlier this year by the owner) Sycamore (large one to front left of plot) needs to be removed prior to shed base replacement as it's disrupting the concrete base by >20cm

Sheds 4 (brown wooden front) - 5 (Grey front)

Large Ash tree at the rear between and behind sheds 5 & 4 - has a number of dead branches, fungal fruiting bodies all around the base and Ganaderma fungus throughout. Within a meter of the school boundary, and leaning somewhat in this direction this Ash poses a significant risk to the school and needs removing.

Twin trunked Ash to front right of shed 5 - has ash die back and is showing signs of stress - requires removal.

Shed 5 (Grey front) - Blue Container 6

Ash tree at the front and just to the right of Container 6, has die-back – for complete removal.

Two Willows between Shed 5 and the blue container (Shed 6): Front willow is leaning heavily on the blue container (shed no. 6), gradually pushing it over, is a poor quality tree and has clearly died and re-spouted. Rear willow nearest to the school is leaning/weighted backwards over the school, prone to branch failure - risk of a branch falling on school & playground. Remove all.

Blue containers 6 - 7

The Willow behind & left of blue container (shed No. 6) that leans towards No. 3 Stable Mews is not currently diseased, it is not a good quality tree however and will likely go the same way as the other two. We will remove this Willow to prevent a future issue.

Small ash at the back behind the bottom blue container (Shed no. 7) has significant die back and signs of stress, and is close to the school boundary – within 50cm.

Blue Container 7 to fencing at rear of 2 & 3 Park Mews

Sycamore to left of Container 7, towards 3 Stable Mews and Millwood Close is healthy and has had crown reduction and thinning carried out around 3-4 years ago. No health or safety indication for removal. However residents having issues with path root damage and TV signal. Bill had no objections to it's removal.
