## Identification of Tree(s) and Description of Works

Western Red Cedar on rear boundary of property - to be reduced in height by 2.5m -3m, as the tree is getting tall enough to block out enough light to the property, the terrace is constantly slippery and dangerous and there are also fears it's top may snap out, as there is significant movement in high winds. Both trees are in very close proximity to house.

Oak, also on rear of property and situated next to Cedar - a canopy reduction of 15% to be performed to generally maintain the tree, limit leaf fall onto the terrace (contributing to Algae and Moss growth) and to allow more light into the garden. Reducing the canopy would also lower the risk of storm damage as the trees are less than 10m from the house.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
