

T15. Tilia cordata (lime). Remove dead wood, raise crown to 3m from ground level to improve light and carry out aerial inspection. T16. Acer pseudoplatanus (sycamore). Reduce five Southwest side laterals by 1.5m to balance crown and improve form/shape. Remove dead wood and remove epicormic growth up to 5m from ground level to improve light. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
