T1 horse chestnut - Tip reduction of lateral horizontal branches to a horizontal radial canopy spread of 7m to create an even, natural domed form. Crown lift to 5m. Remove epicormic growth on the main stem to 5m.

T2 sycamore - Crown reduction from 17.5m height to 10m with a horizontal radial branch spread of 4.5m to create an even, natural domed form. Crown lift to 4m. Remove epicormic growth to 4m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
