T1- Young Ash tree approx 12m in height, identified by National Trust during Ash Dieback (Hymenoscyphus fraxineus) inspections of having 40% or above dieback within the canopy, fell as proactive management as the tree is adjacent to a building.

 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
