Replacement of front facing windows due to condition (please see photos of current windows).

- Due to extensive rot damage and dilapidation, we are replacing the sash pairs to match the existing design, fitted into the existing Box frames. The sashes will be manufactured with Accoya sustainable wood. They match the look of the existing sash windows.
- The configuration of each sash pair is 8 panes over a single pane. The top sashes have evenly spaced panes, with three glazing bars and one lay rail. The top sashes have simple chamfered horns of 100mm (30 / 70mm chamfer) which will be replicated.
- The energy efficiency of the panes is being improved by fitting them with 14mm clear double-glazed units, Argon gas-filled with a U Value of 1.4. The glazing will be fixed with frame sealant and finished with a traditional Putty finish, using Butyl Putty as per the manufacturer's recommendations.
- The Hardwood sills are being replaced (due to extensive rot damage and dilapidation) using Sapele Hardwood to the traditional Box sill design, matching the existing style.
- New Lead counterweight will be used in the existing Box frames, which have sufficient depth to incorporate the heavier counterweight required. The original pulleys will be retained unless judged too fragile at the time of fitting when they will be replaced by matching new ball-bearing pulleys with a tolerance for the new load.
