Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

1. Oak tree (13378) – Pollard tree to principal nodes to reduce canopy by approximately 2m all round as it continues to drop debris and presents a risk of damage to property and the safety of those using the pathway and neighbour's garden.
2. Scots Pine (13382) - Remove large exposed overhanging limb on safety grounds. This limb was close to the Scots Pine (13381) that broke in high winds previously and is of a similar size and aspect (with respect to the predominant wind direction) to the Scots Pine (13387 refers) limb that was removed on safety grounds recently.
3. Scots Pine (13376) – Fell this tree as its proximity to two other Scots Pine trees has forced it to lean in search of canopy space. The amount of lean has increased over the past two years and its roots are now significantly damaging the concrete/tarmac driveway below. The tree top movement has become more severe in recent years with increasing wind volatility and there is a real risk that this tree will fall causing significant damage to the house services and two neighbouring properties. A safety risk cannot be discounted should anyone be in proximity if it fell.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
