Tree Safety Survey carried out by Forest and Tree Consulting Ltd, 40 Church Street, Trawden, Lancashire, BB8 8RU and undertaken by Hugh Wilson MSc BSc M.Arbor A.

Also a letter and photographs submitted by Mr and Mrs Openshaw of 6 Cousin Fields, Bromley Cross, Bolton, BL7 9YQ, to the Development Management, Town Hall, Victoria Square, Bolton on the 21st November 2023. Their property border onto 37 Grange Park Road and are concerned about possible damage to their property, which has happened before, with photo's of previous damage.

Mr Nuttall is concerned that he might be liable for any damage, or more seriously, any injury or fatality to Mr and Mrs Openshaw and would therefore prefer that the trees in question be removed completely and not just trimmed.

Both the trees are Sycamore. Total removal of both trees for safety reasons.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
