#### T1 Holm Oak

Owner would like to crown reduce the tree overall by approximatly 2.5-3m leaving the crown with a spread of approximatly 13m wide and 12m height after completion.

Reasons are to allow more light and reduce the potential risk of limb failure in the future.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
