T1 - Semi Mature Scots Pine - This tree is a concern for the owner and also the neighbors behind. If this tree were to fail it would most likely caused harm to the neighbours and/or their property. In the recent high wind the tree has been making cracking sounds and there are obvious signs of bark inclusion in the upper crown. This combined with its top heavy form (sail) and its inappropriate location (shading and dropping of deadwood) leads us to request removal to near ground level.

To be replaced with a native broad leaved species in a more suitable location
