This application is to inform the local authority of the planned removal of two conifer trees and one dead blossom tree

T1 Conifer tree - complete removal - Excessive shading and unable to reduce size and height whilst keeping tree in good health due to lack of maintenance by previous owner.

T2 Conifer tree - complete removal - Excessive shading and unable to reduce size and height whilst keeping tree in good health due to lack of maintenance by previous owner.

T3 - Conifer tree - complete removal - Lack of maintenance is causing excessive shading and unable to complete a crown reduction due to tree type.

Blossom Tree which was previously T3 will be removed due to the fact it is dead and will cause risk to members of the public due to close proximity to the road and foot path - complete removal due to dieing / dead and risk posed to owners property and close proximity of public foot path. No permission required due to tree been dead. Alternative trees are to be planted in the rear garden as replacements to these trees.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
