Removal of three elderly yew trees on south boundary - out grown their location
Surveyor identified the trees as posing a great risk to the retaining dry stone
boundary wall. They are positioned precariously on the top of the 3 metre wall, their
roots causing mechanical damage due to their size.
The wall has been repaired and rebuilt over the years including three stone
butresses to support it below the trees. We have been advised that it is likely

We will have to repair /rebuild the wall in the short term.
The agricultural track directly below is in constant use, the trees provide a grave safety risk to the farm vehicles. The public foot path that follows the track is in regular use by dog walkers putting the public in danger from the over hanging trees 15 feet above them.
Surrounding the garden is a beech hedge with poor straggling growth due to the dominance of the yew trees. We'd like to plant additional beech hedge to fill in the gaps.
The garden has been neglected for many years.
