Fell to ground level (variation from tree survey - when in leaf this tree has very thin crown and likely infected with Meripulus making failure likely)

T832 - Cedar of Lebanon Fell to ground level

T834 - Beech Crown lift to 3 metres

T835 - Goat Willow Prune clear of building by up to 3 metres and sever ivy

T836 - Oak Prune clear of building by 1 metre
