Purple Plum (T1) located in rear garden of Rushmans Cottage - Reduce the two limbs hanging over the boundary with Brambles. The smaller limb to the south reduce by approximately 2 - 2.5m. The larger limb to the north reduce by approximately 3m to the included union. Crown lift to approximately 3m by removing two secondary limbs approximately 40mm in diameter.
