Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

To remove recent growth, undertake required crown thinning of a Prunus and a Pear Tree in back garden.

In the front garden, the Damson Tree is very old. One branch has split away from the main trunk and is hanging dangerously. We are also advised that the tree is infected with a fungus that is spreading throughout the tree and will, over time, kill it. We will try to save as much of the tree as possible and the work involved will be both Crown Thinning and Crown Reduction.

Given the precarious condition of the overhanging branch, which needs rapid removal, we request your urgent approval of this request so we can undertake the work because from a health and safety perspective, the branch could fall and injure someone.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
