I am working on your application and happily we are almost ready to validate, but we just have a query on the proposal. Your application states 'fell one dead eucalyptus and one deteriorating purple acer both on Scottsdale's site' – yet on the species plan provided in your previous email it is states 2 Maples (which could be classed as Acers also) to prune overhang. Do you still require a Purple Acer to be felled? If so where on the plan it is located? Also reduce back by how much?

To be clear this is how your application looks so far:-

Reduce back to boundary by 2m – 5m trees overhanging from the Hideaway, 35 High Street

comprising T1. Conifer Leylandi, T2 Beech, T3 Conifer Leylandii, T4 Beech, T5 Beech, T6 Ash, T7 Ash

On Scotdales Garden centre side

T8 Eucalyptus dead Fell

T9 Maple - reduce back to boundary by how much?

T10 Maple- reduce back to boundary by how much?

T11 Ash Diseased - Fell

We have to be clear with tree works applications as they are often checked by the public so information has to be correct, but if you could clarify and confirm the outstanding queries where necessary and email me, then I can proceed.

I have marked your plan with a blue box showing where the trees are. The trees that are overhanging into Scotsdales are owned by Mr Ian Hull, 64 High Street, Horningsea. Ian just happens to be an employee of Fordham Landscapes Ltd and we have discussed at length the works with him.

Two of the trees (Ash & Eucalyptus) are in poor condition within the blue box and are in

Scotsdales grounds and are owned by them. These two will require total removal.

Reduce back to boundary varying between 2m and 5m. Height to remain untouched.

1. On the application the 'Location address' refers to where the trees stand – a

further plan is attached so that we can see who we need to write to in relation to ownership.

2. The applicant seems to be Scotsdales but you have stated that they owe the trees which does not appear to be correct? The plan should help in this respect though.
3. Finally, the tree works stated as 'side up' is not an appropriate description. It would be better to state - reduce back to boundary for example by 'x' amount of metres and reduce the overhang back to boundary by 'x' amount of metres.
