branches showing a few leaves - Fell and replace.

Tree 191: Pinus Strobus, Tree is diseased with possible Pine blight or White pine blister rust. Entire top half of tree crown now appears deceased - Fell. (Tree doesn't need replacing as it is in close proximity to a juvenile Cedar tree.)
