Description Field Maple (T1) - Acer campestre
Approximate height - 15 metres
Approximate crown width East to West - 9.5 metres
Approximate crown width North to South - 13.8 metres
Works
Prune back lateral branches away from power line by 1.5 metres
Prune back lateral branches away from building by 1.5 metres
Reduce the remaining crown by 1.8 metres maintaining good form and shape .
Reduce the height of the tree by 2.5 metres to maintain good form and shape.
Remove any dead or dying branches within the crown.
The above works are required in order to mitigate possible damage to power line, roof tiles and guttering by direct action.
In addition the above works are required to mitigate the subsidence risk to the corner of the house which stands 7 metres away and a brick
wall less than 1metre away - also the tree blocks sunlight from entering the front living room.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
